A BILL

6 **For an ordinance amending Denver Revised Municipal Code Section 2-428**
7 **concerning the purposes and allowed uses of monies in the city disposable bag**
8 **fee fund.**

9
10 **WHEREAS**, Denver is committed to being a leader in waste prevention, diversion, and
11 circularity;

12 **WHEREAS**, Denver’s leadership in waste reduction through its passage of the Disposable
13 Bag Fee policy has resulted in the avoidance of more than 50,000,000 plastic bags since 2021;

14 **WHEREAS**, Disposable Bag Fee Fund revenue generated by the \$0.10 fee on disposable
15 bags has been used, to date, to administer the program, provide education, support community
16 cleanups, help restaurants transition away from single-use service ware, and distribute free,
17 reusable bags to the public; and

18 **WHEREAS**, updating and expanding the allowable uses of the Fund enables the ongoing and
19 successful implementation of the Disposable Bag Fee Program, including single-use waste reduction
20 efforts and communitywide waste reduction and circular economy priorities that further expedite
21 progress towards Denver’s citywide waste diversion goals.

23 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
24 **DENVER:**

25 **Section 1.** That Section 2-428 of Denver Revised Municipal Code is amended by deleting
26 the language stricken below and adding the language underlined below to read as follows:

27 **Sec. 2-428. Purposes and allowed uses of monies in city disposable bag fee fund.**

28 Monies from the disposable bag fee shall be used to defray the costs to the city for administering the
29 disposable bag fee program and related activities, ~~which may include~~ including specifically the
30 following ~~specific~~ uses:

31 (a) Administrative costs associated with developing, implementing, and administering the
32 disposable bag fee;

33 (b) Costs to Pprovide reusable carryout bags to residents and visitors;

1 (c) Educate residents, businesses, and visitors about the requirements of the
2 program and impact of disposable bags on the city's environmental health, the importance of
3 reducing the number of disposable plastic bags and other single-use products entering the waste
4 stream, and the expenses associated with mitigating the effects of disposable bags on the city's
5 drainage system, transportation system, recycling system, wildlife, and environment;

6 (d) ~~Fund~~ Programs and infrastructure that allow the city to reduce waste associated with
7 disposable bags and other single-use products;

8 (e) ~~Purchase and install~~ Equipment designed to minimize bag pollution, including,
9 recycling containers, and waste receptacles associated with disposable bags and other single-use
10 products;

11 (f) ~~Fund~~ Community cleanup events and other activities that reduce trash associated
12 with disposable bags and single-use products;

13 (g) ~~Mitigate~~ Mitigation for the effects of disposable bags and single-use products on the
14 city's drainage system, transportation system, recycling system, wildlife, and environment;

15 (h) ~~Conduct~~ Studies of disposable bag usage and the impact of the disposable bag fee
16 in Denver;

17 (i) ~~Maintain a public website that educates residents on the progress of waste reduction~~
18 ~~efforts associated with disposable bags and single-use products; and~~

19 (j) ~~Develop a task force to analyze the data and impact, and to recommend~~
20 ~~improvements.~~

21 (i) Programs, policies, events, and infrastructure to advance Denver's circular economy,
22 such as support to local and regional end markets and reuse and repair initiatives;

23 (j) Education, coordination, resources, and compliance-related support for citywide
24 universal recycling and composting requirements impacting multi-family and commercial properties,
25 permitted events, and construction and demolition projects; and

26 (k) Special or catalytic investments into the city's residential solid waste programs that
27 support citywide waste diversion goals.
