A BILL

6 **For an ordinance changing the zoning classification for 5101-5115 North**
7 **Milwaukee Street in Elyria Swansea.**

9 **WHEREAS**, the City Council has determined, based on evidence and testimony presented at
10 the public hearing, that the map amendment set forth below conforms with applicable City laws, is
11 consistent with the City’s adopted plans, is in the public interest, and is consistent with the
12 neighborhood context and the stated purpose and intent of the proposed zone district;

13 **NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
14 **DENVER:**

15 **Section 1.** That upon consideration of a change in the zoning classification of the land area
16 hereinafter described, Council finds:

- 17 a. The land area hereinafter described is presently classified as E-SU-D.
- 18 b. It is proposed that the land area hereinafter described be changed to U-TU-C.

19 **Section 2.** That the zoning classification of the land area in the City and County of Denver
20 described as follows shall be and hereby is changed from E-SU-D to U-TU-C:

22 **5101 N Milwaukee**

23 Lots Twenty-five (25) and Twenty-six (26), Block Two (2), North Swansea Addition,
24 according to the recorded Plat Thereof, City and County of Denver, State of Colorado

25 **5115 N Milwaukee**

26 Lots 27 and 28, Block 2, North Swansea Addition, City and County of Denver, State
27 of Colorado

30 in addition thereto, those portions of all abutting public rights-of-way, but only to the centerline
31 thereof, which are immediately adjacent to the aforesaid specifically described area.

32 **Section 3.** That this ordinance shall be recorded by the Manager of Community Planning and
33 Development in the real property records of the Denver County Clerk and Recorder.
