Monies received from unspent state child welfare services or other sources of 20 receipts shall be deposited into the Treasury of the City and credited to Special Fund No. 13000. 21 which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and 22 County of Denver. 23 Section 3. Expenditures are hereby authorized for the "Child Welfare Services " fund

Program, Accounting No. 13310-5530000, in the amount not to exceed the total of deposits

described in Section 2 of this Ordinance, to be expended by the Manager of Safety. Authorized

expenditures will include, but shall not be limited to personnel, training, equipment, travel, supplies
