Requests approval to extend the term of the Lease Agreement (FINAN-202580172) with EAST DENVER COLFAX PARTNERSHIP for 3 months to March 31, 2026. The Amendatory Lease Agreement (FINAN-202683028-01) with The Fax East Colfax Redevelopment, LLC is to lease 38 residential rooms/units located at 8405 and 8415 East Colfax Avenue for \$315,418.23 and add \$50,000 to the major repairs reimbursement aggregate. With this amendment, the new maximum contract amount will be \$1,058,961.91.

The Lease Agreement and Amendatory Lease Agreement are in support of Roads to Recovery, which connects people struggling with addiction or mental health to a coordinated system of care. Program participants enter a coordinated, high-touch system for immediate intervention and treatment to support long-term stability. Roads to Recovery case managers will provide services to program participants at this location. The Division of Real Estate is currently working with Roads to Recovery to post an RFP for potential motel partners in 2026.
