## AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT is made between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City"), and FSH Communications, LLC, a Delaware limited liability company (the "Consultant" or "FSH"). Each party may individually be referred to as a "Party" or collectively as the "Parties."

## WITNESSETH:

**WHEREAS**, the Parties entered into an Agreement dated December 1, 2009 to provide payphone operations (the "Agreement"); and

**WHEREAS**, the Parties wish to amend the Agreement to update the locations of the pay phones, amend the Term, and to update other contract language as follows: and

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

- 1. All references to "...Schedule B..." in the existing Agreement shall be amended to read: "...Schedule B-1, as applicable...". The Exhibit marked as Schedule B-1 is attached and incorporated by reference.
- **2.** Article **4** of the Agreement entitled "**TERM OF AGREEMENT**" is hereby amended to read as follows:
  - "4. <u>TERM</u>: The term of the Agreement is from July 1, 2009 through June 30, 2015, unless terminated earlier pursuant to the provisions of this Agreement."
- **3.** A new paragraph numbered **36** is hereby added to the Agreement reading as follows:
  - 36. ELECTRONIC SIGNATURES AND ELECTRONIC RECORDS: Consultant consents to the use of electronic signatures by the City. The Agreement, and any other documents requiring a signature hereunder, may be signed electronically by the City in the manner specified by the City. The Parties agree not to deny the legal effect or enforceability of the Agreement solely because it is in electronic form or because an electronic record was used in its formation. The Parties agree not to object to the admissibility of the Agreement in the form of an electronic record, or a paper copy of an electronic document, or a paper copy of a document bearing an electronic signature, on the ground that it is an electronic record or electronic signature or that it is not in its original form or is not an original.
- **4**. This Amendatory Agreement may be executed in counterparts, each of which shall be deemed to be an original, and all of which, taken together, shall constitute one and the

same instrument.

**5.** Except as herein amended, the Agreement is affirmed and ratified in each and every particular.
