5. Describe the proposed ordinance, including what the proposed ordinance is intended to accomplish, who's involved

a. Scope of Work

Denver Parks and Recreation has negotiated an agreement with the non-profit Denver Inner City Parish to administer programs for the community at College View. Denver Parks and Recreation will partner with Denver Inner City Parish to provide programming for youth in the College View neighborhood. Denver Inner City Parish will provide the following programs.

- **A Seniors Program:** which would work to enhance the health, social well-being and quality of life for community residents 55 years and older. Services would include crafts, games, chair yoga classes, other health and fitness activities, lunches and occasional excursions and special events such as dances and parties.
- **A Food Bank:** the food bank would be a no boundary program open two times per week. Canned goods, produce, bakery items and occasionally meat would be provided.
- **A G.E.D/Night School Program:** This educational program would be open two to three evenings per week to people 16 and older where they would receive tutoring and coaching in order to pass the G.E.D. exam.
- **An After School Program:** a program for elementary aged children four afternoons per week that would be a combination of homework time, play, activities, crafts and snacks.
- **A Summer Day Camp:** this elementary aged children's program is an all-day, five days per week program that runs for 10-weeks per summer. This programs goals are to offer a structured and positive summer program that reinforces the education which students receive in school and to provide activities throughout the day that keep the kids active and safe. Breakfast and lunch are provided; this affordable program is offered on a

sliding scale. Due to time restrictions we would not have this program in place until the summer of 2011

- **A Summer Breakfast and Lunch Program:** a free breakfast and lunch will be offered to children under 18 years old on weekdays. This program would also start during the summer of 2011.

With the exception of the Summer Day Camp all programs would be free of charge. Additionally, Denver Inner City Parish will provide hours for open community use of the center.
