Self Insured Retention (deductible) the maximum amount the City must pay for any one incident resulting in a WC death/injury or deaths/injuries.

• July 1981 – July 1985: \$250,000

• July 1985 – July 1987: \$350,000

• July 1987 – July 1995: \$500,000

• July 1995 – December 2001: \$1,000,000

January 2002 – December 2002: \$2,000,000 City Employees

\$3,000,000 DIA

\$4,000,000 Police/Fire

January 2003 – December 2007: \$3,000,000

• January 2008 – December 2008: \$2,500,000

• January 2009 –May 2015: \$2,500,000





OUCH!

If a City and County of Denver Department of Finance employee is injured at work just call the "Ouch Line"

(303)436-OUCH (6824)

The "OUCH" line connects you with a Denver Health Advice Nurse trained in triage of workers compensation injuries, and it is the new way to report any work injury or illness.

Before you seek any medical care or emergency care for a work-related injury, that is not life threatening, you must call (303) 436-OUCH to report your claim.

Call for triage and, if needed, a referral for medical care. Before you go anywhere for care call the OUCH LINE.

Section 8-43-404 (5) (a) (I) (A) of the Colorado WC Act states:

"In all cases of injury, the employer of insurer shall provide a list of at least two physicians

or two corporate medical providers or at least one physician and one corporate medical provider, where available, in the first instance, from which list an injured employee may select the physician who attends said injured employee. "

When an employee contacts the Ouchline they are provided a choice of medical provider, either COSH (Denver Health) or Concentra.
