**A bill for an ordinance making supplemental appropriations from the General Contingency Fund to Departments;**

**WHEREAS**, the Hearing Office needs a budget adjustment for unbudgeted increased staffing costs due to position upgrades, changed benefit costs and wellness incentive; and

**WHEREAS**, the City Attorney needs a budget adjustment to cover a shortfall within the Liabilities and Claims Special Revenue Fund for 2016 due to projected liabilities; and

**WHEREAS**, the Office of Human Resources needs budget adjustments due to an increase in benefit costs, position upgrades, retirement payouts, Total Rewards Study, and additional staffing; and

**WHEREAS**, the Office of the Clerk and Recorder needs a budget adjustment for additional funding to continue the records maintenance project to preserve historical documents; and

**WHEREAS**, the Office of Economic Development needs a budget adjustment to offset unbudgeted separation payouts; and

**WHEREAS**, the Denver Sheriff Department needs a budget adjustment to fund salary increases negotiated as part of the 2016-2017 bargaining agreement after the 2016 budget was enacted; and

**WHEREAS**, the Office of Special Events needs budget adjustments to offset unbudgeted staffing costs; and

**WHEREAS**, Human Rights and Community Partnerships needs a budget adjustment to offset unbudgeted staffing costs due to position upgrades and changed benefit costs;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

1       **Section 1.** From appropriations heretofore made from the General Fund listed or indicated  
 2 in the following tabulation there is hereby RESCINDED the amount listed or indicated in such  
 3 tabulation under the heading "Amount Rescinded" and transferred to the General Fund:


