A BILL

For an ordinance approving a proposed Intergovernmental Agreement between the City and County of Denver and the State of Colorado, relating to the “56th Avenue / Pena Improvements” project and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Intergovernmental Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Intergovernmental Agreement under CFDA No. 20.205 between the State of Colorado and the City and County of Denver, a copy of which is duly filed with the City Clerk, Filing No. 17-0343, is hereby approved.

Section 2. The payments made by the State of Colorado to the City pursuant to and under the agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said project is as follows:

Authorization for expenditure of said funds following the execution of said contract will cover the period from September 1, 2017 to September 1, 2022. The City will provide a match of \$958,000.

3 necessary to accomplish the purposes of this Ordinance.
