4 **A RESOLUTION**

5 **Approving and providing for the execution of a proposed Grant Agreement**  
6 **between the City and County of Denver and the United States of America**  
7 **Department of Public Safety, Division of Criminal Justice, concerning the**  
8 **"State's Mission for Assistance in Recruiting and Training (SMART) Childcare**  
9 **Center Project" program and the funding therefor.**

10 **WHEREAS**, the City and County of Denver has given due consideration to said proposed  
11 Grant Agreement;

12 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**  
13 **OF DENVER:**

14 **Section 1.** The proposed Grant Agreement, between the City and County of Denver and the  
15 United States of America, Department of Public Safety, Division of Criminal Justice, for the "SMART  
16 Childcare Center Project" program, which is identified as Grant Number 2023-SP-24-4, a copy of  
17 which is duly filed with the City Clerk, Filing No. 202372053, be and hereby is approved in all  
18 respects.

19 **Section 2.** The payments made by the United States of America, Department of Public Safety,  
20 Division of Criminal Justice, to the City pursuant to and under the Grant Agreement shall be  
21 deposited into the Treasury of the City and credited to Special Revenue Fund No. 12000, which is  
22 set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of  
23 Denver.

24 **Section 3.** That it be and is hereby found and determined that the budget summary of said  
25 program, to be expended by the Executive Director of Safety, is as follows:
