The City periodically submits applications to the Colorado Petroleum Storage Tank Fund for reimbursement of City expenses incurred during remediation of petroleum contamination. To date, the City has applied for \$471,692.25 in connection with remediation activities at the City's Osage Fleet Maintenance site located at 2013 S. Osage Street, Denver, Colorado. An application of \$41,092.47 will be made to the Fund upon approval of this ordinance, and future Fund applications are anticipated for this site. The ordinance will allow the City to accept the \$41,092.47 currently applied for and additional amounts up to the statutory limits. The City anticipates seeking future reimbursement of expenses not to exceed the current statutory limits of \$2,000,000 for this site under the Statute.

**EXECUTIVE SUMMARY**

**Contractor: Colorado Petroleum Storage Tank Fund Contract Control Number: RC 57000-03**

The City currently conducts remediation activities at the Osage Fleet Maintenance site as required by the Colorado Department of Labor and Employment, Division of Oil and Public Safety (OPS; OPS Event ID 3789). This requirement is due to a past release of petroleum product from a former underground storage tank. The Fund allows owners of leaking underground storage tanks to make applications to the Fund for reimbursement of remediation costs. The City periodically submits applications to the Colorado Petroleum Storage Tank Fund for reimbursement of City expenses incurred during remediation of petroleum contamination. To date, the City has applied for \$471,692.25 in connection with remediation activities at the City's Osage Fleet Maintenance site located at 2013 S. Osage Street, Denver, Colorado. An application of \$41,092.47 will be made to the Fund upon approval of this ordinance, and future Fund applications are anticipated for this site.
