4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**
6 **of land as a public alley near the intersection of Park Avenue West and Blake**

9 found and determined that the public use, convenience and necessity require the laying out, opening
10 and establishing as a public alley designated as part of the system of thoroughfares of the
11 municipality that portion of real property hereinafter more particularly described, and, subject to
12 approval by resolution has laid out, opened and established the same as a public alley;

13 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening
15 and establishing as part of the system of thoroughfares of the municipality the following described
16 portion of real property situate, lying and being in the City and County of Denver, State of Colorado,
17 to wit:

18 **PARCEL DESCRIPTION ROW NO. 2016-DEDICATION-0000233-001:**

19 THE SOUTHEASTERLY 2.00 FEET OF LOTS 1, 2, 3 AND 4, BLOCK 35, EAST DENVER,
20 COMMONLY KNOWN AS STECK'S ADDITION TO DENVER,

21 EXCEPT, THE SOUTHWESTERLY 1.50 FEET THEREOF, CITY AND COUNTY OF DENVER,
22 STATE OF COLORADO.

23 SAID PARCEL CONTAINS 197 SQUARE FEET

24 be and the same is hereby approved and said real property is hereby laid out and established and
25 declared laid out, opened and established as a public alley.

26 **Section 2.** That the real property described in Section 1 hereof shall henceforth be a public
27 alley.
