9 For an ordinance approving and providing for the execution of a proposed contract
10 between the City and County of Denver and the State of Colorado concerning the
11 "Mountain Parks Genesee Overlook" project and the funding therefor.

13 WHEREAS, the City and County of Denver has given due consideration to said proposed
14 Contract;

15 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY
16 OF DENVER:

17 Section 1. The proposed Contract, under CFDA No. 20.205, between the State of Colorado
18 and the City and County of Denver, a copy of which is duly filed with the City Clerk, Filing No.
19 10-485, be and hereby is approved in all respects.

20 Section 2. The Mayor or his lawful successor and other proper officials of the City and
21 County of Denver, in its behalf, are hereby authorized and directed to execute said Contract
22 and the Clerk and Recorder of the City and County of Denver is hereby authorized and directed
23 to attest and impress the official seal of the City and County of Denver on the Contract.

24 Section 3. The Mayor, his successor in office, or his duly authorized representatives, and
25 other officials of the City are hereby authorized and directed to do all things required to be done
26 in order to obtain payments under the Contract, including, but not limited to, filing requests for
27 payments, contracting with persons and organizations in order to carry out the provisions of the
28 Contract amendment, filing reports and keeping records relating to fiscal and evaluation matters,
29 and forwarding other materials to the State of Colorado.

30 Section 4. The payments made by the State of Colorado to the City pursuant to and under
31 the Contract shall be deposited into the Treasury of the City and credited to Special Fund
32 No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of
33 the City and County of Denver.
