**A BILL**

**For an ordinance creating a Fund Number in the Grant/Other Capital Projects Fund for the "Broadway, Asbury to IowA" project, and the funding therefor.**

**WHEREAS**, ordinance 32, Series 2011 authorized an Intergovernmental Agreement with the Colorado Department of Transportation relating to reconstruction of Broadway between Asbury and IowA, a copy of which is duly filed with the City Clerk, Filing No. 11-014; and

**WHEREAS**, the Broadway, Asbury to IowA project requires an expenditure authorization, including establishing a new fund number;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** A new fund is hereby established in the Grant/Other Capital Projects Fund, Accounting No. 38000, for the project indicated in the following tabulation:

Authorization for expenditure of said funds will cover the period from execution of contract to project completion and close out.

**Section 2.** Monies received for reimbursements shall be deposited into the Treasury of the City and credited to Grant/Other Capital Projects Fund No. 38000 which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.
