COMMITTEE OF REFERENCE:
Finance & Governance

A bill for an ordinance making a supplemental appropriation from the General Contingency Fund and an appropriation from the Human Services Service Delivery and Administration Fund and the Homeless Services Fund.

WHEREAS, the City desires to acquire property for use as an overflow homeless shelter and general city storage facility; and

WHEREAS, bill request BR16-1318 requests the approval of the purchase of 4330 East 48th Avenue from BCP-48th Avenue I LLC to meet these needs;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:
