**A RESOLUTION**

**Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the Colorado Department of Local Affairs (DOLA) concerning the “City and County of Denver Emergency Migrant Response” grant program and the funding therefor.**

**WHEREAS**, the City and County of Denver is experiencing a significant number of migrants arriving from the southern border; and

**WHEREAS**, Denver is working to meet the needs of these migrants, and the cost of the response is straining city finances and other resources across multiple funding sources and departments; and

**WHEREAS**, the City applied to the State to request funding to help cover the cost of unbudgeted expenditures resulting from the migrant sheltering response, which will continue into the new year; and

**WHEREAS**, through the grant application process, the Colorado Department of Local Affairs approved a grant award in the amount of \$1,500,000 to the City and County of Denver to help fund said sheltering response; and

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Grant Agreement between the City and County of Denver and the Colorado Department of Local Affairs for the “City and County of Denver Emergency Migrant Response” Grant, which is identified as Grant Number MRP-MRP001, a copy of which is duly filed with the City Clerk, Filing No. 202266266, be and hereby is approved in all respects.

**Section 2.** The payments made by the State of Colorado to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 13000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.
