### **CURRENT BOARD STATUS**

**Scope of Board/Commission:** The Cherry Creek North Business Improvement District (BID) is governed by a 13-member Board of Directors comprised of property owners and managers, local business owners and commercial tenants. The Board is tasked with setting forth the strategic direction each year for the BID. The Board also convenes several committees, task forces and working groups throughout the year to advise on the BID's annual strategy and operating plan.

Appointment Process: Mayor appoints 13 and City Council confirms for a term of 3 years.

## Juan Padró - Restauranteur



BIO: Since founding Highland Tap & Burger in 2010, Juan Padró has led The Culinary Creative Group to expand to 20 restaurants, bars, and coffee shops in Denver and New Orleans. Recently nominated to The RH Power List of influential restaurateurs, his establishments have received multiple awards, including Michelin Bib Gourmand recognition for Ash'Kara and Mister Oso.
