10 **For an ordinance approving and providing for the execution of a proposed**
11 **grant agreement between the City and County of Denver and the United**
12 **States of America concerning the "High Intensity Drug Trafficking Area**
13 **(H.I.D.T.A.) FY12" program and the funding therefor.**

16 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
17 Grant Agreement;

18 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
19 **OF DENVER:**

20 **Section 1.** The proposed Grant Agreement, under CFDA No. 95.001 between the United
21 States of America and the City and County of Denver, which is identified as Grant Number
22 G12RM0018A, a copy of which is duly filed with the City Clerk, Filing No. 12-292, be and hereby
23 is approved in all respects.

24 **Section 2.** The payments made by the United States of America to the City pursuant to and
25 under the Grant Agreement shall be deposited into the Treasury of the City and credited to
26 Special Fund No. 12000, which is set forth and described in Section 20-18 of the Revised
27 Municipal Code of the City and County of Denver.

28 **Section 3.** That it be and is hereby found and determined that the budget summary of said
29 "High Intensity Drug Trafficking Area (H.I.D.T.A) FY12" Program, Accounting No. 12002-
30 3518101-S1128 is as follows, to be expended by the Manager of Safety:
