**A BILL**

**For an ordinance re-purposing a "Library" program in the Culture and Recreation Special Revenue Fund (SRF) and the means for authorizing expenditures from such fund.**

**WHEREAS**, fund 15807 (formerly special fund 1549) was established by ordinance No. 98, series of 1983 as the "Conservation of Frank Mechau's Horses at Night" fund; and

**WHEREAS**, activity for said program ceased to exist many years ago and this fund is being used as the "Library" program SRF;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** This is hereby to re-purpose in the Culture and Recreation Special Revenue Fund, Accounting No. 15000, a "Library" program, Accounting No. 15807-0801000, for the purpose of supporting various collections and activities relating to library services.

**Section 2.** Monies received from contributions, donations, charges, fees, investment earnings and program and project incomes or other source of private receipts shall be deposited into the Treasury of the City and credited to Special Fund No. 15000 which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** Expenditures are hereby authorized for the "Library" program, Accounting No. 15807-0801000, in the amount not to exceed the total of deposits described in Section 2 of this Ordinance, to be expended by the City Librarian.
