This Rapid Rehousing program provides crucial housing assistance and support to households who have experienced domestic violence or are currently fleeing a domestic violence situation. This program is the only HOST funded Rapid Rehousing designated specifically for this population and is one of the only domestic violence programs that serves men as well as women. In this program, households will receive housing navigation, deposit and first month's rent assistance, tiered rental assistance and case management support to provide long term housing stability.

Scope of work:

The Green Willow Rapid Rehousing Program focuses on survivors of domestic violence, intimate partner violence, sexual assault and stalking that are fleeing or are attempting to flee these situations. This project utilizes Housing First and Critical Time Intervention models for 30 households in this specialized population to access safe housing in scattered sites throughout the Denver area. The aim of this project is to transition participants into safe and secure permanent housing as soon as possible.

A. The following services will be provided

- housing navigation
- case management services
- referrals to mental health resources
- advocacy
- benefit acquisition
- connection to education and/or employment opportunities
- childcare referrals and options
- short to medium term rental assistance

B. VOA will coordinate with clinical providers to offer in-home therapeutic services for the family as needed

C. VOA will work with a multi-disciplinary team to coordinate care and provide legal assistance to assist with cooperation within the court system and other supports identified by the participant.
