A BILL

For an ordinance amending Ordinance 260, Series 2017, concerning rescinding budget, transferring cash, and making appropriations in the General Fund, General Government and Culture and Recreation Special Revenue Funds of moneys designated by City Council for various projects.

WHEREAS, ordinance 260, series 2017 allowed the rescinding of budget and transferring of cash for various projects designated by City Council; and

WHEREAS, part of this transfer should have been made to the Public Safety Special Revenue Fund, Police Donations Fund instead of the Police General Fund budget;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That Sections 2 of Ordinance No. 260 Series of 2017, be hereby amended to read as follows:

“Section 2. From the General Fund, Accounting No. 01010, out of moneys rescinded in Section 1, and not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1032, Series of 2016, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following each such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
