A BILL

For an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the State of Colorado, Department of Transportation, concerning the "Sobriety Court" program and the funding therefor.

WHEREAS, the City and County of Denver was previously awarded funds from the State of Colorado, Department of Transportation for the same purpose; and

WHEREAS, the total funds received now surpass the threshold identified in Section 20-52 (2) of the Revised Municipal Code of the City and County of Denver; and

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement, under CFDA No. 20.600, between the State of Colorado, Department of Transportation, and the City and County of Denver, a copy of which is duly filed with the City Clerk, Filing No. 12-893-A, be and hereby is approved in all respects.

Section 2. The payments made by the Colorado Department of Transportation to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said "Sobriety Court" Program, Accounting No. 12270-0501101-B2006 is as follows, to be expended by the Presiding Judge of County Court:

Colorado Department of Transportation \$ 225,000

Authorization for expenditure of said funds following execution of said Contract will cover the period from October 1, 2012 to September 30, 2013.

1 **Section 4.** The Manager of Finance of the City and County of Denver is hereby authorized
2 and directed to make such book and record entries and to do such other things as may be
3 necessary to accomplish the purposes of this Ordinance.
