A BILL

For an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the United States of America, concerning the "Assistance to Fire Fighter Grant—Personal Protective Equipment " program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement, under CFDA No. 97.044, between the United States of America, Federal Emergency Management Agency (FEMA), and the City and County of Denver, which is identified as Grant Number EMW-2011-FO-03904, a copy of which is duly filed with the City Clerk, Filing No. 2012-0009, be and hereby is approved in all respects.

Section 2. The payments made by the Federal Emergency Management Agency to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said "Assistance to Fire Fighter Grant—Personal Protective Equipment" Program, Accounting Number 12230-3521101-S1126, is as follows, to be expended by the Manager of Safety.

Federal Emergency Management Agency \$1,399,877

A cash match in the amount of \$349,969 is required by the grant and will be provided by the Fire Department General Fund appropriation, accounting number 01010-3520000. Authorization for expenditure of said funds following execution of said grant will cover the period from December 23, 2011 to December 22, 2012.
