**A BILL**

**For an ordinance authorizing a rescission from and an appropriation in the General Fund to make a cash transfer to the Planned Fleet Replacement Special Revenue Fund and authorizing the purchase of capital equipment in the General Government Special Revenue Fund.**

**WHEREAS**, the Denver Public Library (DPL) requests to purchase a vehicle to support transportation of collection materials and operating supplies between Central Library and the twenty-six library branches located throughout the Denver metropolitan area; and

**WHEREAS**, the Denver Public Library wishes to use current year savings for the purchase of said vehicle; and

**WHEREAS**, to use DPL’s current year savings to support the above need, the City requires a rescission from DPL’s General Fund budget and an appropriation in the General Fund to make a cash transfer to the Planned Fleet Special Revenue Fund, Accounting No. 11804, a non-lapsing revenue-based fund; and

**WHEREAS**, DPL requires authorization to purchase said vehicle from the Planned Fleet Special Revenue Fund;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:

**Section 2.** From the General Fund, Accounting No. 01010, out of monies rescinded from Section 1 not otherwise appropriated and in addition to amounts heretofore appropriated by

1 Ordinance No. 1284, Series of 2021, and any supplemental appropriations or rescissions, there is  
2 hereby appropriated to the appropriation accounts hereinafter designated the amount of money  
3 following such designation, to be expended for the purposes and upon the authorizations in said  
4 Ordinance set forth:

11 Librarian, or a duly authorized representative, is hereby authorized to purchase or acquire the  
12 following capital equipment:
