9 **For an ordinance approving and providing for the execution of a proposed**
10 **grant agreement between the City and County of Denver and the State of**
11 **Colorado concerning the "Community Services Block Grant (CSBG) FY13-14"**
12 **program and the funding therefor.**

15 **WHEREAS**, Ordinance No. 147, Series of 2013, authorized expenditures in the amount of
16 \$458,289 based on a letter of intent from the Colorado Department of Local Affairs to fund the
17 "CSBG FY13-14" program; and

18 **WHEREAS**, the State of Colorado has tendered to the City a Grant award for said program;
19 and

20 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
21 Grant Agreement;

23 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
24 **DENVER:**

26 **Section 1.** The proposed Grant Agreement, under CFDA No. 93.569, between the State of
27 Colorado and the City and County of Denver, which is identified as Grant Number L13CSBG13,
28 a copy of which is duly filed with the City Clerk, Filing No. 13-0696, be and hereby is approved in
29 all respects.

30 **Section 2.** The payments made by the State of Colorado to the City pursuant to and under
31 the Grant Agreement shall be deposited into the Treasury of the City and credited to Special
32 Fund No. 13000, which is set forth and described in Section 20-18 of the Revised Municipal
33 Code of the City and County of Denver.

1 **Section 3.** That it be and is hereby found and determined that the budget summary of said
2 “CSBG FY13-14” Program, Accounting No. 13007-5511101-H2147 is as follows, to be expended
3 by the Manager of Human Services:

7 Authorization for expenditure of said funds following execution of said grant will cover the period
8 from March 1, 2013 to September 30, 2014.

9 **Section 4.** The Manager of Finance of the City and County of Denver is hereby authorized
10 and directed to make such book and record entries and to do such other things as may be
11 necessary to accomplish the purposes of this Ordinance.
