5 **Accepting and approving the plat of Denargo Market Subdivision Filing No. 3.**

6 **WHEREAS**, the property owners of the following described land, territory or real property  
7 situate, lying and being in the City and County of Denver, State of Colorado, to wit:

8 LOT 1, BLOCK 5, DENARGO MARKET SUBDIVISION FILING NO. 2, ACCORDING TO THE  
9 PLAT THEREOF RECORDED APRIL 12, 2012, AT RECEPTION NO. 2012049308, CITY AND  
10 COUNTY OF DENVER, STATE OF COLORADO.

11 SAID PLAT CONTAINS 11.190 ACRES OR 487,424 SQ. FT. MORE OR LESS

12 propose to lay out, plat and subdivide said land, territory or real property into blocks, lots and tracts,  
13 and have submitted to the Council of the City and County of Denver a plat of such proposed  
14 subdivision under the name and style aforesaid, showing the adjacent streets and platted territory,  
15 accompanied by a certificate of title from the attorney for the City and County of Denver; and


16 **WHEREAS**, said subdivision was surveyed by or under the direction of the City Engineer of the  
17 City and County of Denver and said City Engineer has certified as to the accuracy of said survey and  
18 said plat or map and their conformity with the requirements of Chapter 49, Article III of the Revised  
19 Municipal Code of the City and County of Denver, and said plat has been approved by the City  
20 Engineer, the Executive Director of Community Planning and Development, the Executive Director of  
21 the Department of Transportation and Infrastructure and the Executive Director of Parks and  
22 Recreation;

23 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

24 **Section 1.** That the Council hereby finds and determines that said land, territory, or real  
25 property has been platted in strict conformity with the requirements of the Charter of the City and  
26 County of Denver.

27 **Section 2.** That the said plat or map of Denargo Market Subdivision Filing No. 3 be and the  
28 same is hereby accepted by the Council of the City and County of Denver.
