Integral Recoveries, Inc. collects delinquent fines and fees. The Court originally entered into an agreement with Integral Recoveries, Inc. in March of 2009. Since that time they have recovered over 15.5 million dollars. Currently, over 150,000 Denver County Court cases have been placed with them. Integral Recoveries receives 20% of any amount recovered. This cost is passed on to the defendant.
