CURRENT BOARD STATUS

Scope of Board/Commission: : The Denver Commission on Cultural Affairs (DCCA) was established in 1991 to support the Mayor and act as an advisory board for Denver Arts & Venues. The Commissioners serve as trustees of Denver's Cultural Plan and oversee the 1% for Public Art Program. This program enacted into Ordinance by Denver City Council in 1991, directs that 1% of any city-funded capital improvement project over \$1 million is set aside for the inclusion of art, so the collection continues to grow each year. Over \$40 million has been invested in the public art collection, along with historic and donated works of art, providing opportunity for Denver residents to experience art in public places.

Appointment Process: Mayor appoints 24 members to this Commission for a term of three years. City Council confirms.

BIO Daisy McGowan, Executive Director of Think 360 Arts for Learning is a non-profit administration and fundraising professional, educator, curator, author, artist and mother. She has been a leader in the arts and arts education in Colorado for over twenty-five years. McGowan previously served as director for the University of Colorado, Colorado Springs (UCCS) Galleries of Contemporary Art from 2010-2022, where she led the program through a period of tremendous growth and impact on the entire Rocky Mountain west region. McGowan was awarded her Bachelor of Studio Art from Colorado College and Master of Public Administration, with a focus on arts administration, from the University of Colorado. As an educator, she has taught at the university level for nearly twenty years including studio art and museum studies and gallery practice, as well as K-12 arts education.
