13 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
14 Grant Agreement;

16 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**

19 **Section 1.** The proposed Grant Agreement, between the United States of America and the
20 City and County of Denver, for the "Head Start FY24-25 Grant" program, which is identified as
21 Grant Number 08CH012758-01-00, under CFDA No. 93.600, a copy of which is duly filed with the
22 City Clerk, Filing No. 202474418, be and hereby is approved in all respects.

23 **Section 2.** The payments made by the United States of America to the City pursuant to and
24 under the Grant Agreement shall be deposited into the Treasury of the City and credited to
25 Special Fund No. 11000, which is set forth and described in Section 20-18 of the Revised
26 Municipal Code of the City and County of Denver.

27 **Section 3.** That it be and is hereby found and determined that the budget summary of said
28 "Head Start FY2024-2025" Program is as follows, to be expended by the Director of the Office of
29 Children's Affairs:
