6 **For an ordinance changing the zoning classification 5042-44 North Federal**
7 **Boulevard.**

9 **WHEREAS**, the City Council has determined, based on evidence and testimony presented
10 at the public hearing, that the map amendment set forth below conforms with applicable City laws,
11 is in accordance with the Comprehensive Plan, is necessary to promote the public health, safety
12 and general welfare of the City, is justified by one of the circumstances set forth in Section
13 12.4.10.14 of the Denver Zoning Code, and is consistent with the neighborhood context and the
14 stated purpose and intent of the proposed zone district;

15 **NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
16 **OF DENVER:**

17 **Section 1.** That upon consideration of a change in the zoning classification of the land area
18 hereinafter described, Council finds:

- 19 1. That the land area hereinafter described is presently classified as E-CC-3X.
- 20 2. That the Owner proposes that the land area hereinafter described be changed to E-MX-
21 3A.

22 **Section 2.** That the zoning classification of the land area in the City and County of
23 Denver described as follows shall be and hereby is changed from E-CC-3X to E-MX-3A:

25 Lot 7, Friend’s Resubdivison of Block 17 East Berkeley
26 City and County of Denver
27 State of Colorado
28

29 in addition thereto those portions of all abutting public rights-of-way, but only to the centerline
30 thereof, which are immediately adjacent to the aforesaid specifically described area.

31 **Section 3.** That this ordinance shall be recorded by the Manager of Community Planning
32 and Development in the real property records of the Denver County Clerk and Recorder.
