AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT is made and entered into this _____ day of ______, 2010, by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City"), and CEDAR CRESTONE, INC., a Delaware corporation, with an address of 1255 Alderman Drive, Alpharetta, GA 30005 (the "Consultant"). Each party may be individually referred to as a "Party" or collectively as the "Parties."

WITNESSETH:

WHEREAS, the Parties entered into an Agreement dated December 18, 2007, relating to contracting with a professional IT staffing provider for the City's supplemental IT staffing needs (the "Agreement"); and

WHEREAS, the Agreement, expired by its terms on August 31, 2010; and

WHEREAS, rather than enter into a new contract the Parties wish to revive, and reinstate all of the terms and conditions of the Agreement as they existed prior to the expiration of the term and to amend the Agreement to extend the term and update certain insurance language; and

NOW, THEREFORE, in consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

- 1. Article 2 of the Agreement entitled "TERM" is hereby amended to read as follows:
- "2. <u>TERM</u>: The term of the Agreement is from September 1, 2007 through June 30, 2011, unless terminated earlier pursuant to the provisions of this Agreement."
- 2. That article 12(B) entitled "**Proof of Insurance**" of the Agreement is hereby amended to read as follows:

"12. INSURANCE:

B. <u>Proof of Insurance</u>: Consultant shall provide a copy of this Agreement to its insurance agent or broker. Consultant certifies that the attached certificate of insurance (preferably an ACORD certificate of insurance) complies with all insurance requirements of this Agreement. The City's acceptance of a certificate of insurance or other proof of insurance that does not comply with all insurance requirements set forth in this Agreement shall not act as a waiver of Consultant's breach of this Agreement or of any of the City's rights or remedies under this Agreement. The City's Risk Management Office may require additional proof of insurance, including but not limited to policies and endorsements."

3. As herein amended, the Agreement is affirmed and ratified in each and every particular.
