I live on Vrain St near Aruipe Jesuit school/church. I wanted to express my conditional support for the rezoning plan. Some of my neighbors have expressed concern about the street parking situation worsening with future development after rezoning. I think these concerns could be easily addressed by any or all of three possibilities:

- 1. Use existing parking better. The street parking spaces on Utica, between 41st and 44th, directly in front of the school are currently vastly underutilized due to the 8am 8pm 2 hr parking limit regulation. The primary users of this parking would be students parking between 8am and 3pm, who park farther away from the school than necessary (on Vrain or 41st St) but as close as possible on streets without the 2hr limit. This is understandable from the students perspective but silly from a neighborhood and student perspective. There is plenty of available street parking right next to the school but due to 2hr regulations that seem to make no sense, a suboptimal situation results for both students and neighbors of the school. Please change the Utica parking in front of the school to remove the 2 hr limit, so students and teachers can use the closest and most convenient parking available to them, during the times of highest demand.
- 2. Address parking demand. Try to reduce the demand for parking by encouraging (a) the use of buses (both private school buses and public RTD buses), (b) carpooling, and (c) biking/walking when possible. Students could be given RTD vouchers by the school and bike racks or a secure bike parking building/room could be built to encourage non-car travel and discourage bike theft. These would be less expensive than building additional parking.
- 3. Add parking supply. The most expensive option would be to build additional parking, for example, by building a parking structure on the existing surface parking lot. This would likely be quite expensive and would not contribute the expanding the school's teaching and learning capacity (which I understand is their goal, and which I fully support).

Hopefully, a sensible plan for parking, incorporating one or more of the above ideas, can be included in any development plans following the rezoning. #1 in particular seems like a "no brainer" that could be implemented in less than a day by simply taking down a few signs on the block of Utica between 41st and 44th, directly adjacent to the rezoned properties.

As proposed, I have serious concerns with the re-zoning application for Arrupe Jesuit High School. The application does not identify any meaningful ways to address the serious parking issue we have during school days. For this application to be approved, you must require them to not just meet the minimum of 1 vehicle per 1,000 s.f. per the ordinance but exceed that by at least 3 times.

I live at 44th and Vrain, my house looks directly at the parking lot, and every school day my street and the surrounding streets are absolutely crammed with vehicles. The two way streets become incredibly crowded with vehicles parked on both sides so it's hard for vehicles to pass each other. It's also difficult for pedestrians and cyclists to see around intersections for any vehicles because there's parked cars pushing the limits of the existing public parking boundaries. Come pickup time, you have some vehicles idling in areas that don't allow street parking making the roads even more dangerous.

After reviewing the zoning ordinance it appears that a high school is held to the same minimum parking requirements as an elementary school and middle school. The key difference is in high school, not only are the teachers and staff parking for the day, but students old enough to drive are as well. The minimum parking requirements are not adequate in this circumstance so a 3x the minimum should be required.

It's clear that a school with an already known parking issue, should not be permitted to expand without proper parking space to handle all these vehicles.
