6 **For an ordinance relinquishing an easement established in the Deed recorded**
7 **with the Denver Clerk & Recorder at Book 3539, Page 393, and number**
8 **1925817859, located at 810-870 East 50th Avenue.**

9 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
10 found and determined that the public use, convenience and necessity no longer requires the
11 easement in the area hereinafter described, and subject to approval by ordinance, has relinquished
12 the same;

13 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in relinquishing the
15 easement established in the Deed recorded with the Denver Clerk & Recorder at Book 3539, Page
16 393, and number 1925817859 in the following area:

17 **PARCEL DESCRIPTION ROW NO. 2018-RELINQ-0000017-001:**

18 A PARCEL OF LAND LOCATED IN THE SOUTHWEST QUARTER OF SECTION 14, TOWNSHIP
19 3 SOUTH, RANGE 68 WEST OF THE 6TH PRINCIPAL MERIDIAN, CITY AND COUNTY OF
20 DENVER, STATE OF COLORADO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

21 CONSIDERING THE WEST LINE OF THE SOUTHWEST QUARTER OF THE SOUTHWEST
22 QUARTER OF SECTION 14 TO BEAR NORTH 00°08'02" WEST, A DISTANCE OF 1331.18
23 FEET BETWEEN A FOUND 3.25" ALUMINUM CAP STAMPED "1994 LS 16401" AT THE
24 SOUTHWEST CORNER OF SECTION 14 AND A FOUND ILLEGIBLE 2.5" ALUMINUM CAP AT
25 THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST
26 QUARTER OF SECTION 14, WITH ALL BEARINGS CONTAINED HEREIN RELATIVE
27 THERETO.

28 BEGINNING AT THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE
29 SOUTHWEST QUARTER OF SECTION 14; THENCE ALONG THE NORTH LINE OF SAID
30 SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER, NORTH 89°41'48" EAST, A
31 DISTANCE OF 846.46 FEET; THENCE SOUTH 47°17'11" WEST, A DISTANCE OF 7.41 FEET;
32 THENCE ALONG A LINE PARALLEL WITH AND 5.00 FEET SOUTHERLY FROM SAID NORTH
33 LINE, SOUTH 89°41'48" WEST, A DISTANCE OF 841.00 FEET TO A POINT ON SAID WEST
34 LINE OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER; THENCE ALONG
35 SAID WEST LINE, NORTH 00°08'02" WEST, A DISTANCE OF 5.00 FEET TO THE POINT OF
36 BEGINNING.




