8 For an ordinance making rescissions and appropriations in the General Fund.

9  
10 WHEREAS human resource services have been consolidated in the Career Service  
11 Authority; and

12 WHEREAS the Career Service Authority needs additional funding to implement the human  
13 resource shared services, which will be offset by budget rescissions in other General Fund  
14 agencies and by revenue for billing non-General Fund agencies for human resource services;  
15 and

16 WHEREAS the American Recovery and Reinvestment Act mandated that employers  
17 provide a subsidy for COBRA continuation premiums for qualified beneficiaries who were  
18 involuntary terminated from employment; and

19 WHEREAS the expenditures for the COBRA continuation premiums are centralized in the  
20 Career Service Authority and will be reimbursed by the Federal Government, but were not  
21 budgeted;

23 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY  
24 OF DENVER:

25 Section 1. From appropriations heretofore made from the General Fund listed or indicated  
26 in the following tabulation there is hereby RESCINDED the amount listed or indicated in such  
27 tabulation under the heading "Amount Rescinded" and transferred to the General Fund
