Dear Ms. Rutz:

Thank you for your response to BRUN's comment letter of August 21, 2025. While some of BRUN's questions were addressed, it is disappointing to see that the PUD application provides no development plan showing various land uses across the site, including the amount or type of housing that will be constructed. While the University has recognized some of BRUN's concerns, it has not altered the PUD application to substantively address its previous comments. Overall, BRUN's biggest concern is that there is no certainty as to what will be constructed on this site. Because there is no development plan attached to the PUD application, there is no commitment to the extent of retail uses along Federal Blvd., as well as the extent and type of housing. Much of the site could be taken up by a hospital and other University administrative uses with little space dedicated to housing. This broader scope intent greatly reduces the housing component previously shown to BRUN to the detriment of community needs. Based on previous meetings, presentations and online information, different conceptual plans have been presented, but none has been included in the PUD application. **Is there a development plan that corresponds with the PUD application? And if so, can it be shared with the BRUN Community prior to the October 15<sup>th</sup> Denver Planning Board meeting?**

As the largest landowner in the Berkeley Regis neighborhood, the University has utilized the site mainly for their benefit, and the PUD application continues this approach. BRUN has a vested interest in how development of this property is consistent and compatible with not only the community at large, but also the adjacent neighbors. BRUN has expressed its concerns about this compatibility throughout various discussions with Regis University and its representatives.

Although currently disappointed, BRUN hopes that the University remains true to their values of community engagement, allowing BRUN and the adjoining neighbors to have continued input as the development of this important property progresses.


