BR13-1005 Approves a loan agreement with the Denver Housing Authority to provide an \$800,000.00 performance loan for the construction of a 77 unit mixed–income rental housing project (Mariposa Phase IV). Eighteen of the units will be replacement public housing Units; 34 units will be affordable for households with incomes between 50% and 60% of the Area Median Income (AMI); and 24 units will be market rate units.

BR13-1006 Approves a first amendment to the Tax Regulatory Agreement with Emanuel Grant Company, LLC for the Capitol Heights Apartments in Council District 10.
