- a. Tier II services include but are not limited to intensive case management, life and work skills classes, career exploration, Adult Basic Education (ABE), GED/HSE attainment, and ongoing post-job placement support.
 - i. Tier II households may not initially meet full participation within TANF due to short term barriers that are being resolved
 - ii. It is anticipated that long term family income will be through employment earnings
- b. Tier III services include but are not limited to intensive case management, life and work skills classes, career exploration, parent classes, connection to employment supports as well as services and resources to family stabilization.
