A BILL

For an ordinance authorizing a rescission and an appropriation in the Climate Protection Special Revenue Fund to make a cash transfer to the Climate Protection Capital Projects Fund.

WHEREAS, the Adopted 2025 Budget includes an appropriation in the Climate Protection Capital Fund to support the Energize Denver Program; and

WHEREAS, cash for said appropriation will come from 2024 budget savings in the Climate Protection Special Revue Fund; and

WHEREAS, the City desires to make a rescission from and an appropriation in the Climate Protection Fund to make the cash transfer to the Climate Protection Capital Projects Fund to support the Energize Denver Program in the Adopted 2025 Budget; and

WHEREAS, this ordinance is a companion to Ordinance 1539, Series of 2024 establishing the 2025 Annual Appropriation;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the Climate Protection Special Revenue Fund, Accounting No. 11880, listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
