A BILL

For an ordinance authorizing cash transfers from the Convention Center Replacement Fund to close said Fund.

WHEREAS, the Convention Center Replacement Fund was established in 1989 to support improvements to the Colorado Convention Center; and

WHEREAS, this Fund is no longer needed, and the Capital Planning and Programming Division wishes to transfer the remaining cash balance to the Colorado Convention Center Capital Fund to serve as reserves for future COP payments to protect against the volatility of revenue sources;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. There is hereby authorized the transfer of cash from the Convention Center Replacement Fund to the Colorado Convention Center Capital Fund in the amounts indicated in the following tabulation:

The Convention Center Replacement Fund shall be closed after transacting the above transfer.

Section 2. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary

2 the impact of transactions that may occur prior to the passing of this Ordinance.
