BR14-0249 Adds \$300,000 and extends the term for the existing contract with The Western Stock Show Association (Association) to pay the Association for parking fees collected by the City on a small piece of Association property adjacent to the Coliseum (CE85029).

BR14-0267 Approves the rezoning of 4300 East Warren Avenue and 4275 East Iliff Avenue from PUD 205 to G-MU-3 in Council District 6.

C. Denver International Airport - Amy Raaz

BR14-0274 Approves a 15-month, \$7,904,081.77 contract with Sturgeon Electric Company, Inc. for the Runway 8-26 Complex Lighting Rehabilitation Project if an Airport Improvement Program (AIP) grant is received.
