A BILL

For an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the University of Colorado concerning the "Integrating Trauma-Informed and Trauma-Focused Practice in Child Protective Service" program and the funding therefore.

WHEREAS, the University of Colorado has tendered to the City a Grant award for said program; and

WHEREAS, pursuant to Denver Revised Municipal Code (DRMC) Section 20-52, inasmuch as the Integrating Trauma-Informed and Trauma-Focused Practice in Child Protective Service program for 2012-2014, in combination with the Integrating Trauma-Informed and Trauma-Focused Practice in Child Protective Service program for fiscal year 2015, will exceed \$500,000; and

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement, under CFDA No. 93.652, between the United States of America and the City and County of Denver, which is identified as Grant Number 90CO1059-04, a copy of which is duly filed with the City Clerk, Filing No. 12-0309-C, be and hereby is approved in all respects.

Section 2. The payments made by the United States to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 13000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

1 **Section 3.** That it be and is hereby found and determined that the budget summary of said
2 “Integrating Trauma-Informed and Trauma-Focused Practice in Child Protective Service” program,
3 Accounting No. 13001-5511101-H1210 is as follows, to be expended by the Manager of Human
4 Services:

8 The foregoing authorization will provide integrating trauma-informed and trauma-focused practice
9 services in child welfare cases. Authorization for expenditure of said funds following execution of
10 said grant will cover the period from September 30, 2014 to September 29, 2015.

11 **Section 4.** The Manager of Finance of the City and County of Denver is hereby authorized
12 and directed to make such book and record entries and to do such other things as may be
13 necessary to accomplish the purposes of this Ordinance.
