CR11-0865 **COMMITTEE OF REFERENCE:** 3 SERIES OF 2011 Land Use, Transportation & Infrastructure 4 A RESOLUTION 5 Laying out, opening and establishing as part of the city street system certain 6 tracts created by Lowry Filing No. 17. 7 8 WHEREAS, the Manager of Public Works of the City and County of Denver has found and 9 determined that the public use, convenience and necessity require the laying out, opening and 10 establishing as public streets designated as part of the system of thoroughfares of the municipality 11 those portions of real property hereinafter more particularly described, and, subject to approval by 12 resolution has laid out, opened and established the same as public streets; 13 NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF 14 **DENVER:** 15 16 Section 1. That the action of the Manager of Public Works in laying out, opening and establishing as part of the system of thoroughfares of the municipality the following described 17 18 portion of real property situate, lying and being in the City and County of Denver, State of 19 Colorado, to wit: 20 (1) Oneida Ct., from the southeast corner of block 9 approximately 80.0 feet east to
