**A BILL**

**For an ordinance naming the unnamed park at 3800 West Alameda Avenue as “Cuatro Vientos/Four Winds Park”.**

**WHEREAS**, the City County of Denver acquired in 2009 an entire block at 3800 West Alameda Avenue (Block 4, Lots 3 through 18, Belmont Park, City and County of Denver) for the purpose of creating a new park; and

**WHEREAS**, in accordance with the procedure established by the Department of Parks and Recreation’s Naming Policy, residents of southwest Denver submitted a petition to name the unnamed park at 3800 West Alameda Boulevard “Cuatro Vientos/Four Winds Park”.

**WHEREAS**, the Manager of the Department of Parks and Recreation supports the proposed naming of this park and the Denver Parks and Recreation Advisory Board voted at its meeting on July 11, 2013, to recommend the naming of the unnamed park at 3800 West Alameda Avenue as “Cuatro Vientos/Four Winds Park”.

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** That the unnamed park at 3800 West Alameda Avenue be and the same is hereby named, and shall be known as, CUATRO VIENTOS/FOUR WINDS PARK.

**Section 2.** That this action shall be effective upon the final adoption of the ordinance.
