## CB13-0650 A bill for an ordinance approving a proposed Second Amendment to Agreement between the City and County of Denver and RTL Networks Inc. related to on-call technology maintenance and support services at Denver International Airport.

Adds \$400,000 and two years to the contract with RTL Networks, Inc. for technology consulting services at Denver International Airport (CE-15008).
