8	WHEREAS, the City and County of Denver owns an historic horse-drawn buggy by the Parks					
9	and Recreation Department; and					
10	WHEREAS, the horse-drawn buggy is a part of the City's museum collection at the Buffalo Bill					
11	Museum and Grave ("Museum"), located in Lookout Mountain Park; and					
12	WHEREAS, since acquiring the horse-drawn buggy, the Museum has been unable to display					
13	the item due to its size; and					
14	WHERES, has determined	d that the horse-drawn buggy does not have a direct connection with				
15	the historical individuals or events	s that are the subject of the Museum's purpose, and as a result, the				
16	horse-drawn buggy is outside of	the Museum's mission and scope of collection; and				
17	WHEREAS, the museum	s a cultural institution that holds historical materials in the public trust				
18	and is a member of the American Alliance of Museums, and as a result, intends to comply with the					
19	best practices of this organizatio	n; and				
20	WHEREAS, the Museum	has nonetheless determined that rather than auction the horse-				
21	drawn buggy as surplus, it is mo	ore appropriate and reflective of the horse-drawn buggy's historic				
22	nature to donate the horse-draw	n buggy to another museum or similar institution; and				
23	WHEREAS, the City, afte	r a search among several historical institutions, has further identified				
24	the Gilpin County Historical Socie	ety, which has a similar mission regarding the preservation of historic				
25	items, as the recipient of the hor	se-drawn buggy, subject to approval of this bill; and				
26	WHEREAS, the proposed	donation of a surplus horse-drawn buggy, restored and retaining its				
27	historic nature and quality, from the	ne City and County of Denver to the Gilpin County Historical Society,				
28	cannot be made until after appro	val by the Council of the City in accordance with subsection 2.9.3				
29	(C), Part 9, of Article II of the Ch	arter of the City; and				
30	WHEREAS, the Executive	Director of General Services has determined that the horse-drawn				
31	buggy, no longer on display at the	e Museum is surplus and the donations is in the best interests of the				
32	City; and					

1	WHEREAS the Mayor has duly reviewed and approved the proposed donation.
2	NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF
3	DENVER:
4	Section 1. Subject to availability, the proposed donation of a surplus horse-drawn buggy
5	from the City to the Gilpin County Historical Society is hereby approved.
