Regular routine preventative maintenance, corrective maintenance, replacements, and emergency response services are crucial to mitigate the associated safety and operational impacts and to extend DEN's electric security perimeter vehicle gates. Expedited time-critical repairs and/or replacements are essential to ensure stakeholders can gain access to the airfield and can have a direct impact on Federal Aviation Administration (FAA) Part 139 compliance.
