The section of sidewalk addressed in this project is located along the east side of South University Boulevard between East Exposition Avenue and Polo Club Lane. The installation of the sidewalk segments will provide connections to RTD transit stops and will require two (2) partial acquisitions and one (1) temporary easement. All of these are located on residential parcels.

- RW-01 (480 S. University Blvd.) – is located near the west property line, abutting the right-of-way along S. University Blvd.
- RW-02 (680 S. University Blvd.) – is located near the SW corner of S. University Blvd. and E. Exposition Ave.
- TE-02 (680 S. University Blvd.) – is located near the SW corner of S. University Blvd. and E. Exposition Ave.

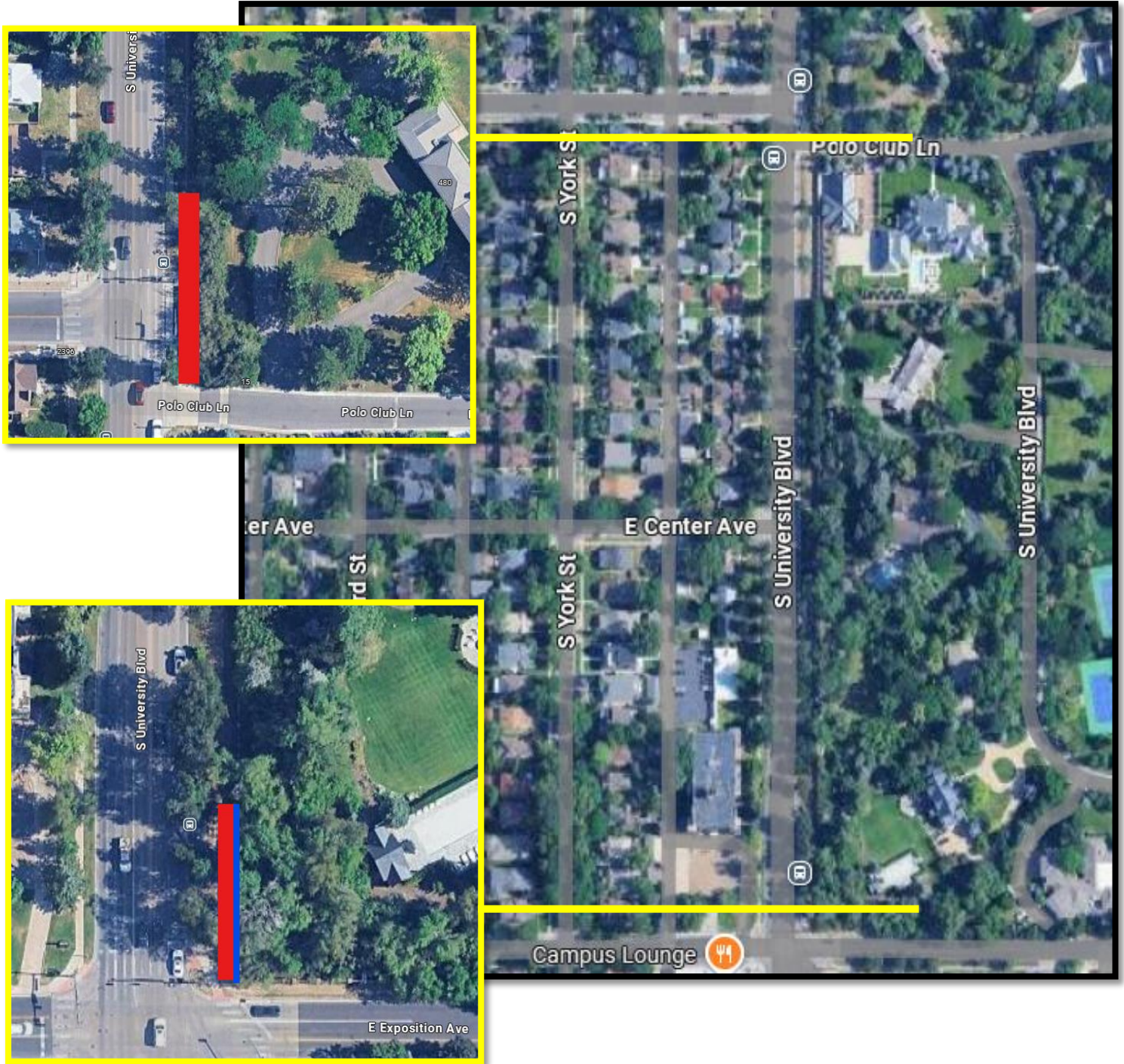
