5 **A BILL**

6 **For an ordinance authorizing a cash transfer from the City Council Special**  
7 **Revenue Fund to the General Fund and making an appropriation in the**  
8 **General Fund.**

10 **WHEREAS**, in April 2020, the Budget and Management Office asked all General Fund  
11 agencies to meet reduction targets to help address the projected revenue gap resulting from  
12 economic impact of COVID-19; and

13 **WHEREAS**, City Council chose to address a portion of its target by adding revenue to the  
14 General Fund through transfers from the City Council Special Revenue Fund;

16 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
17 **OF DENVER:**

19 **Section 1.** There is hereby authorized the transfer of cash from the City Council Special  
20 Revenue Fund to the General Fund the amount indicated in the following tabulation:

27 **Section 2.** From the General Fund, Accounting No. 01010, out of monies transferred in Section  
28 1 not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance  
29 No. 1193, Series of 2019, and any supplemental appropriations or rescissions, there is hereby  
30 appropriated to the appropriation accounts hereinafter designated the amount of money following

1 such designation, to be expended for the purposes and upon the authorizations in said Ordinance  
2 set forth:
