A RESOLUTION

Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the Arapahoe County, Community Resources Department, concerning the “The Denver Regional Council of Government, Green Workforce Hub Initiative” program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement between the City and County of Denver and the Arapahoe County, Community Resources Department, concerning the “The Denver Regional Council of Government, Green Workforce Hub Initiative” program, which is identified as Grant Number WP3QXJ87RYH3 a copy of which is duly filed with the City Clerk, Filing No. 202683458, be and hereby is approved in all respects.

Section 2. The payments made by the Arapahoe County, Community Resources Department, to the City pursuant to and under the Grant Agreements shall be deposited into the Treasury of the City and credited to Economic Opportunity Special Revenue Fund Series, Accounting No. 17000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of Denver Economic Development and Opportunity, is as follows:

The foregoing award is a pass-through grant from the Environmental Protection Agency, through the Denver Regional Council of Governments, Assistance Listing Number 66.046.

Expenditures of said funds are authorized for the period from October 9, 2025 through October 16, 2029.

Section 4. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Resolution.
