**A BILL**

**For an ordinance authorizing a rescission and an appropriation in the Climate Protection Special Revenue Fund to make a cash transfer to the Climate Protection Capital Projects Fund.**

**WHEREAS**, the Office of Climate Action, Sustainability, and Resilience (CASR), Renewable Denver Community Solar Program, installs community solar gardens for solar carport projects hosted at Denver Public School highs across the City and County of Denver; and

**WHEREAS**, CASR has received approval from Xcel Energy (and the Colorado Public Utilities Commission who authorizes Xcel to approve community solar programs) to move forward with installing five new solar gardens at Denver High Schools; and

**WHEREAS**, CASR had budgeted \$10,000,000 of funds in the Climate Protection Special Revenue Fund to be used for the Community Solar Program, pending approval Xcel; and

**WHEREAS**, to use said funds, the budget and cash need to be in a capital appropriation; and

**WHEREAS**, the City desires to make a rescission from and an appropriation in the Climate Protection Fund to make a cash transfer to the Climate Protection Capital Projects Fund to support the Solar Infrastructure Improvements Capital Program appropriation;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the Climate Protection Special Revenue Fund, Accounting No. 11880, listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":

 12 amount of money following such designation, to be expended for the purposes and upon the  
 13 authorizations in said Ordinance set forth:
